**UNANIMOUS CONSENT AGREEMENT**

S. 937 (CALENDAR NO. 13)

1.—*Ordered*, That on Thursday, April 22, 2021, upon the conclusion of Morning Business, the Senate resume consideration of S. 937, a bill to facilitate the expedited review of COVID–19 hate crimes, and for other purposes; provided, that the following amendments be reported by number and be the only amendments in order:

—Cruz-Kennedy Amdt. No. 1456

—Lee Amdt. No. 1425

—Blackburn Amdt. No. 1458;

provided further, that at 11:30 a.m., the Senate vote in relation to the amendments in the order listed; further, that Amdt. No. 1445, offered by the Senator from New York (Mr. Schumer), as amended, if amended, be agreed to; provided further, that the bill be considered read a third time, and the Senate vote on the passage of the bill, as amended; further, that 60-affirmative votes be required for adoption of the amendments and passage of the bill, with four minutes for debate, equally divided, prior to each vote, with no intervening action or debate; provided further, that the motions to reconsider be considered made and laid upon the table with no intervening action or debate. (*April 21, 2021.*)
