UNANIMOUS CONSENT AGREEMENTS**H.R. 3935 (ORDER NO. 211)**

1.—*Ordered*, That on Wednesday, May 1, 2024, following the confirmation vote on the Alexakis nomination, the Senate resume Legislative Session and resume consideration of the motion to proceed to H.R. 3935, an Act to amend title 49, United States Code, to reauthorize and improve the Federal Aviation Administration and other civil aviation programs, and for other purposes; provided, that the motion to invoke cloture on the motion to proceed ripen at 3:00 p.m.; provided further, that the mandatory quorum call under Rule XXII be waived. (*April 23, 2024.*)

H.R. 7791

2.—*Ordered*, That if the Senate receives a message from the House of Representatives that it has passed H.R. 7791, a bill to amend the Internal Revenue Code of 1986 to postpone tax deadlines and reimburse paid late fees for United States nationals who are unlawfully or wrongfully detained or held hostage abroad, and for other purposes, and if the text is identical to S. 4057, a bill to amend the Internal Revenue Code of 1986 to postpone tax deadlines and reimburse paid late fees for United States nationals who are unlawfully or wrongfully detained or held hostage abroad, and for other purposes, H.R. 7791 be considered as having been read three times and passed, and the motion to reconsider be considered made and laid upon the table. (*April 30, 2023.*)

S.J. RES. 4 (ORDER NO. 3)

3.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S.J. Res. 4, a joint resolution removing the deadline for the ratification of the Equal Rights Amendment, the mandatory quorum call under Rule XXII be waived. (*April 25, 2023.*)

S. 326 (ORDER NO. 32)

4.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 326, a bill to direct the Secretary of Veterans Affairs to carry out a study and clinical trials on the effects of cannabis on certain health outcomes of veterans with chronic pain and post-traumatic stress disorder, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*April 20, 2023.*)
